

## Pre Examination Changes – April 2010

The Council is proposing a number of Pre-Examination Changes to Plan E, which it would like the Planning Inspector to consider and recommend. The proposed changes are considered to be of a minor nature, which include spelling, grammatical or factual updating changes and improvements to the soundness of the plan that do not affect the fundamental strategy of the submitted DPD.
