6. Every monument when first erected or when re-fixed after an interment shall have a foundation consisting of not less than two reinforced concrete bearers, such bearers to be at least 3 feet 6 inches in length, 1 foot 6 inches in width, and 3 inches in thickness, and shall otherwise be constructed in all respects to the Council's satisfaction. Bearers shall also be provided where the monument is placed on a landing or one piece foundation frame. Memorials must not exceed 6 feet 6 inches in length and 2 feet 6 inches in width. Lawn memorials must be fixed by drilling and dowelling to the existing concrete foundation.
7. All spoil is to be removed from site.
8. **All** memorial works will be carried out in the Cemetery on a **STRICTLY BY APPOINTMENT ONLY BASIS.**
9. The section letter and number of the grave space must be cut in a prominent position on all memorials erected or placed in the cemetery.
10. The memorial remains the property and responsibility of the Grantee (owner). Epsom & Ewell Borough Council will conduct periodic memorial safety checks in accordance with current Health & Safety legislation.

The Drawing of the proposed Memorial, with all dimensions marked thereon in plain figures is attached hereto. I certify all particulars on this application to be true and correct, and undertake that all and any other works carried out by me or on my behalf shall conform to the current NAMM Code of Practice.
