One of the licensing objectives which underpins the Licensing Act 2003 is the prevention of crime and disorder and all operators are expected to take steps to promote the licensing objectives.

Home Office (Immigration Enforcement) believe MR BILAL GILGIL is not preventing crime and disorder and therefore should no longer be allowed to hold a premises licence. MR BILAL GILGIL is using his restaurant business to employ illegal workers which is strictly prohibited under the Licensing Act 2003 and Immigration Act 1971(aa).

Employing illegal workers in the UK has the following impact on the community and society as a whole:-

- 1. It deprives HMRC and the Government of revenue by non-payment of tax and national insurance.
- 2. It exploits the undocumented by paying them less than the minimum wage and provides no employment or income protection.
- 3. It encourages other overstayers / illegals to seek similar work.
- 4. It allows a business to unfairly undercut other businesses by employing cheap labour.
- 5. Illegal workers are often housed in cramped and unsatisfactory conditions by the employer as part of their working arrangement.

EPSOM GRILL is a takeaway in the town of Epsom, Surrey. The premises has a licence to sell hot food (late night refreshments between the hours of 2300-0200 Monday to Sunday.

Home Office (Immigration Enforcement) have received information stating that the employer is knowingly allowing people that have no right to be working in the UK, to be working at the premises.

As a result of this intelligence, Home Office (Immigration Enforcement) together with Officers from Surrey Police planned an Enforcement visit which was conducted on 27 January 2023 with entry being gained by Immigration Officers from South Central ICE under Section 179 of the Licencing Act 2003.

On arrival Immigration Officers encountered a total of 5 people, of which 4 were of Turkish nationality and 1 was from Iran.

2 arrests were made by Immigration officers due to illegal working and checks also showed that these people had entered the UK illegally.

Officers also encountered a minor working at the address, he was in the care of social services and later reunited with a family member.

There was accommodation above the premises, which was only accessible via the shop, in the accommodation there were three rooms. The employees confirmed to Officers during investigation that they did stay in this accommodation.

The Manager at Epsom Grill who was present at the time Officers visited confirmed that they do not do checks on their staff and stated he sometimes pays cash in hand to his employees. He stated that there was no set rate and that this would depend on employee's experience.

He also confirmed to officers when questioned about 1 of his employees that 'he had not made a decision whether he was going to pay him or not' and he confirmed that he was aware that this person has no right to be working in the UK.

A referral notice was served to the manager Bilal GILGIL, and this is currently being considered by the Home Office Civil Penalties team who will decide on whether the business will be issued with a penalty fine.

Revised Home Office guidance issued under section 182 of the Licensing Act 2003 – December 2022 states:

11.26 Where the licensing authority is conducting a review on the grounds that the premises have been used for criminal purposes, its role is solely to determine what steps should be taken in connection with the premises licence, for the promotion of the crime prevention objective. It is important to recognise that certain criminal activity or associated problems may be taking place or have taken place despite the best efforts of the licence holder and the staff working at the premises and despite full compliance with the conditions attached to the licence. In such circumstances, the licensing authority is still empowered to take any appropriate steps to remedy the problems. The licensing authority's duty is to take steps with a view to the promotion of the licensing objectives and the prevention of illegal working in the interests of the wider community and not those of the individual licence holder.

11.27 There is certain criminal activity that may arise in connection with licensed premises which should be treated particularly seriously. These are the use of the licensed premises:

• for employing a person who is disqualified from that work by reason of their immigration status in the UK:

11.28 It is envisaged that licensing authorities, the police, the Home Office (Immigration Enforcement) and other law enforcement agencies, which are responsible authorities, will use the review procedures effectively to deter such activities and crime. Where reviews arise and the licensing authority determines that the crime prevention objective is being undermined through the premises being used to further crimes, it is expected that revocation of the licence – even in the first instance – should be seriously considered.
